1. NAME OF THE SOCIETY

The Name of the Society shall be "St. Claret Education Society, Chimur".

2. REGISTERED OFFICE

The Registered Office of the society shall be situated in the State of Maharashtra. Its Present Address is Near Government ITI, Nery Road, Chimur, District Chandrapur, M.S. - 442 903.

3. AIMS AND OBJECTS

The Society is a Christian Minority Educational Institution governed by the relevant articles of the Constitution of India dealing with the minority rights.

The Aims and Objects for which the Society is established are as follows :

- a) To Establish and run schools, colleges, hostels for students irrespective of caste, creed, sex and age.
- b) To take over, conduct the existing institutions with similar objects or akin thereto, and to run any educational institution in furtherance thereof.
- c) To establish new institutions and to develop, expand or support the existing ones for the purposes mentioned in the Memorandum and to hold in trust any such institutions for the purposes thereof.

- e) To hold and to conduct classes, lectures, conferences, seminars, and competitions and to give scholarships, freships, diplomas, certificates and awards as and when thought fit.
- f) To educate, train, equip and assist them financially and/or otherwise in the educational training and equipment of employees or other persons for the purpose of the Society.
- g) To do and/or to cause to be done any such acts or things which are conducive to/or incidental to the main objects and aims of the Society
